

Sevier County Sheriff's Office Specifications for Uniforms 2015-16

The vendor selected will be responsible for providing satisfactory service as it pertains to all uniform needs to include but not limited to:

- 1) Maintain an adequate inventory of approved uniform and uniform accessory items that are detailed in the Sevier County Sheriff's Office bid. Vendors shall furnish on request proof that the selected vendor can provide the uniforms requested.
- 2) Receive, process, and fulfill individual orders in a timely manner.
- 3) Perform standard alterations in-house to uniform items as needed (no additional charges for standard alterations).
- 4) Provide in-house personalized embroidery services in accordance with the Sevier County Sheriff's Office standards/requirements.
- 5) Maintain accurate and timely accounting of paid/unpaid invoices and also maintain accurate records of products received/not received by the Sevier County Sheriff's Office.
- 6) Selected vendor must have a uniform facility (store front) to include sample items, adequate inventory for SCSO approved uniforms and accessories, and a trained staff that will assist to ensure proper fitting occurs. **(Note: Store front will be located within a reasonable distance of the Sevier County Sheriff's Office to ensure that the SCSO has easy access to the vendor's store.)**
- 7) Selected vendor will provide SCSO with details concerning warranties, returns, and replacement policies.

- 8) Selected vendor will provide the SCSO with all patches, name tag strips, flag patches, rank insignia, etc. All prices pertaining to the above listed uniform accessories will include the process of sewing them on the uniforms.
- 9) Provide prices on all patches needed by the SCSO which are:
American Flag, Sevier County Sheriff's Office patch, badge patch, Correction Badge patch, Name Tag Strip (1" x 6"). **(Note: Badges and rank insignia will be created on a patch and then sewn onto the uniform.)**
- **Corrections Uniform Specs: Men's/Women's Short-Sleeved Professional Polo Shirt**, 5.11 Tactical Series Style # 41060, 41060T or comparable.
Men's /Women's Tactical Pant, 5.11 Tactical pants style
Men's/Women's Jacket, 5.11 Response jacket style
Buckle-less Belt, prefer basket weave, leather, and approximately 8-10 ounces in weight. Sizes should range from XS (28-30) through 4XL (56-58).
Boots, regular and wide width, side zip 9 inch boot.
 - **Patrol Uniform Specs (Class "A")**: Men's/Women's Shirt needs to be the Flying Cross by Fechheimer item #UD12000 or comparable.
Men's/Women's Pants needs to be Flying Cross by Fechheimer item #3900 or comparable.
 - **Patrol Uniform Specs (Class "B")**:
Men's/Women's PDU S/S Taclite Class B Shirt style #71167 or comparable.
Men's/Women's PDU Taclite Class B Cargo Pant style #74371 or comparable.

Delivery: Selected vendor will be required to deliver uniforms within an acceptable time frame for vendor and the Sevier County Sheriff's Office. Uniforms must be delivered to 106 West Bruce Street, Sevierville, TN 37862 (no delivery fees).

NOTE: The selected vendor will retain this contract for a period of five (5) years as long as the price of the uniforms/uniform accessories doesn't exceed three (3%) percent from this bid.
